FOREWORD

This publication sets forth important information concerning the bills passed by the Hawaii State Legislature during the Regular Session of 2000, which adjourned *sine die* on May 2, 2000. This publication supplements the publication entitled “Bills Passed by the Hawaii State Legislature, Regular Session of 2000” which was issued by the Legislative Reference Bureau in May 2000 . That publication contains a brief description of each bill passed during the 2000 session.

This report contains the following:

- (1) A general index that contains a topical listing of the bills passed in 2000 under broad and general subject matter categories.
- (2) “Laws Affected by Bills Passed” shows sections of the Hawaii Revised Statutes, the Session Laws of Hawaii, and sections of the Hawaiian Homes Commission Act, 1920, that are affected by bills passed by the Legislature in the 2000 Regular Session. It also includes a listing of new chapters of the Hawaii Revised Statutes and proposed constitutional amendments. This table reflects information from the final draft of every bill passed by the Legislature.
- (4) “Status of Bills Passed by the Legislature” is a listing of bills passed, and includes the Act number and approval date, if any, and the appropriate committee report numbers.
- (5) A preliminary table of H.B. No. 1900, C.D. 1, Supplemental Appropriations Act of 2000, furnished courtesy of the Tax Foundation of Hawaii, shows the total program appropriations for fiscal years 1999-2000 and 2000-2001.

The above information includes act numbers and approval dates for bills signed into law or vetoed by the Governor as of May 22, 2000.

For your information, the Governor has 45 days after adjournment *sine die* (not counting Saturdays, Sundays, and holidays) to consider bills for approval.

We sincerely hope that this publication will be of assistance to you. Please be reminded that there is no substitute for knowing what a bill says other than consulting the bill itself. If you are interested in obtaining further information, please contact our office.
