FOREWORD

This publication sets forth all of the requests made by the Hawaii State Legislature during the Regular Session of 2009 to agencies and officials of the federal, state and county governments and of quasi-public and private agencies. These requests are contained in acts enacted by the Legislature or bills passed which have yet to be approved by the Governor. These acts or bills include specific requests for submission of information back to the Legislature excluding annual and other reports requested on an indefinite basis. These requests are also contained in resolutions adopted by the Senate or House of Representatives or by the whole legislature. Dates by which reports and other responses are expected are indicated when specifically set by the Legislature. The names of the agencies involved in the conduct of a study or the execution of a request are underscored.

For the reader's convenience these legislative requests are also grouped together by agencies (see agency index); as well as by subject matter (see subject index).

ACT 13

SB 190, SD1, HD2

COMMUNITY CARE FOSTER FAMILY HOMES, ALLOWING TWO PRIVATE-PAY INDIVIDUALS TO BE IN THE SAME HOME. Requires the Department of Human Services to establish and implement a two-year demonstration project to allow two private-pay individuals to be cared for in the same community care foster family home and to monitor and evaluate the project for its impact on the availability of space for medicaid clients.

Further requires the Department to submit a report of its findings and recommendations to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

SB 1108

'AHA MOKU COUNCIL SYSTEM. Extends the 'Aha Kiole Advisory Committee to June 30, 2011, and requires the Committee to submit another interim report of its findings and recommendations on the 'Aha Moku Council System to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010, and a final report no later than twenty days prior to the convening of the Regular Session of 2011.

ACT 54

SB 718, SD1, HD1

HIGHWAY DESIGN. Establishes a temporary task force to review existing state and county highway design standards and guidelines to determine standards and guidelines that can be established to provide consistency for all highway users, propose changes to highway design standards and guidelines, and make recommendations for restructuring procedures, rewriting design manuals, and creating new measures to track success.

Requires the members of the task force to be selected by the Director of Transportation, and shall include one member representing:

- (1) The Department of Transportation;
- (2) The Department of Health;
- (3) Each county's Public Works Department or Transportation Department;
- (4) Hawaii Bicycling League;
- (5) Peoples Advocacy for Trails Hawaii;
- (6) American Association of Retired Persons Hawaii;
- (7) Hawaii Highway Users Alliance;
- (8) University of Hawaii's Department of Urban and Regional Planning or Department of Civil and Environmental Engineering;
- (9) Developers;
- (10) Federal Highway Administration; and
- (11) Other interested parties.

Requires the task force to submit through the Department of Transportation an interim progress report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010, and a final report, including findings, recommendations, and proposed legislation to the Legislature, no later than twenty days prior to the convening of the Regular Session of 2011.

FEDERAL STIMULUS FUNDS. Requires the Governor to report to the Legislature prior to allowing and an increase in the federal stimulus fund authorization ceiling.

SB 1, SD1, HD2, CD1

OPIHI HARVESTING AND POSSESSION, RESTRICTION. Requires the Division of Aquatic Resources of the Department of Land and Natural Resources to submit an annual report on the effectiveness and enforcement of the restrictions on opihi harvesting and possession to the Legislature no later than twenty days prior to each Regular Session of 2011, 2012 and 2013.

SB 55, SD1, HD1, CD1

PUBLIC ACCOUNTANCY, PERMIT TO PRACTICE. Requires the Director of Commerce and Consumer Affairs to report the progress and status of the adoption of rules to apply for and obtain a permit to practice public accountancy to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

SB 387, SD1, HD1, CD2

DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM, TRANSFER FROM. Requires the Legislative Reference Bureau to review this Act for the purpose of making recommendations as to the appropriate placement of parts or chapters of the Hawaii Revised Statutes affected and submit its findings and recommendations, accompanied by any necessary proposed legislation, to the Legislature by January 1, 2010.

SB 389, SD1, HD2, CD1

DEPARTMENT OF EDUCATION AND DEPARTMENT OF BUDGET AND FINANCE, AGREEMENT BETWEEN. Requires the Legislative Reference Bureau to review the memorandum of understanding between the Department of Education and the Department of Budget and Finance for the allotment of capital improvement projects, with the goal of replicating the processes of the memorandum of understanding for use by other state agencies with many capital improvement projects that are predominantly funded by general obligation bonds.

SB 415, SD2, HD1, CD1

HOME CARE AGENCY CLIENTS AND HOME CARE LICENSING PROGRAM. Requires the Department of Health to report any recommended proposals to ensure the prevention of financial exploitation of home care agency clients and to improve the home care licensing program to the Legislature, no later than twenty days prior to the convening of the Regular Session of 2010.

(SSCR 408, 659, HSCR 1162, 1677, CCR 145)

SB 496, SD2, HD2, CD1

Requires the Charter School Review Panel to establish criteria and an approval process for the development and submission of a capital improvement projects budget for charter school facilities, and recommendations to allocate non-per-pupil facilities funds to charter schools with facilities needs, including:

- (1) A calculation showing the per-pupil funding based on the Department of Budget and Finance's debt service appropriation for the Department of Education divided by the Department of Education's actual enrollment that school year; and
- (2) A determination of the portion of the amount appropriated to be allocated to start-up charter schools on a per-pupil basis.

Further requires the Panel to report its findings and recommendations, including any budget requests and proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

SB 536, SD1, HD1, CD1

STARLIGHT RESERVE STRATEGY TO PRESERVE THE QUALITY OF THE NIGHT SKY. Requires the Department of Business, Economic Development, and Tourism to submit a final report on the starlight reserve strategy to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

(SSCR 551, HSCR 1289, 1728, CCR 84)

SB 972, SD2, HD1, CD1

TAX ENFORCEMENT. Requires the Department of Taxation to report on the resources committed to implementing enforcement and the additional revenues raised to the Legislature no later than thirty days prior to the convening of each Regular Session. Repealed on June 30, 2014.

CANNABIS, MEDICAL USE. Requires the Director of Public Safety to submit a report on the medical cannabis task force's findings and recommendations, including any proposed legislation and rules, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

(SSCR 341, 634, HSCR 1194, 1711, CCR 131)

SB 1218, SD2, HD2, CD1

MORTGAGE LOAN REGULATION. Requires the Commissioner of Financial Institutions to prepare a report detailing the implementation the Secure and Fair Enforcement for Mortgage Licensing Act which includes an evaluation of administrative rules necessary for the implementation of this Act, budget recommendations, requests for staff and resources, developments in federal law and regulations that affect the implementation of this Act, and guidance or recommendations put forth by the United States Department of Housing and Urban Development.

Further requires the Commissioner to report findings, recommendations, and any proposed amendments or additions to this Act to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

HAWAII MADE PRODUCTS LAW, LABELING ISSUES. Requires the Chair of the Board of Agriculture to convene a working group composed to identify labeling issues relating to the Hawaii-made products law and to propose workable solutions, including solutions for enforcement and submit a report of its findings to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

(SSCR 580, HSCR 1029, 1241, 1694, CCR 95)

SB 1350, SD2, HD1, CD1

RESERVED HOUSING PROGRAM, KAKAOKO COMMUNITY DEVELOPMENT DISTRICT, OAHU. Requires the Hawaii Community Development Authority to submit a report on the status of its reserved housing program in the Kakaako community development district which includes:

- (1) The total number of reserved housing units contained in the Kakaako community development district at the time of the report, broken down with regard to:
 - (A) Size and type of unit;
 - (B) Age group of occupants of the units; and
 - (C) Whether the units were sold or rented;
 - (2) The number of reserved housing units that were provided or are under construction at the time of the report as a result of the requirements of this Act;
 - (3) A recommendation whether the reserved housing requirements contained in this Act should be reduced, remain unchanged, or increased; and
 - (4) Any other information that it deems relevant to its reserved housing program in the Kakaako community development district
- to the Legislature no later than twenty days prior to the convening of the Regular Session of 2014.

PART II, SECTION 17

INTEGRATED ELECTRONIC FILING SYSTEM FOR FEE TIME SHARE INTERESTS. Requires the Bureau of Conveyances to submit a written report on the implementation of the system to the Legislature no later than twenty days prior to the convening of the Regular Session of 2012.

PART II, SECTION 18

DEREGISTRATION OF FEE INTEREST. Creates in the Bureau of Conveyances an employer-employee working group to resolve any issues that may arise in the implementation of deregistration of fee interest and to make recommendations for the recovery of lost revenue due to deregistration of time shares. Requires the group to submit a report of its findings and activities to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

SB 1665, SD2, HD1, CD1

WORKFORCE DEVELOPMENT. Requires the University of Hawaii Community Colleges Skilled Worker and Business Development Center to submit a report on the progress achieved regarding the establishment and start-up of the skilled worker and business development center; the development plan for the skilled worker and business development center; funding options, recommendations, and requirements for the skilled worker and business development center and the specific programs thereunder at the various community colleges, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

SB 1674, SD2, HD2, CD1

UNIVERSITY OF HAWAII ADDITIONAL REVENUE BONDS. Requires the University of Hawaii to notify the Legislature upon the issuance of the additional revenue bonds.

HB 183, HD1, SD2, CD1

SECTION 8

TEACHER STANDARDS BOARD, AUDIT. Requires the Legislative Reference Bureau to review the findings of the Legislative Auditor's Report No. 09-05, and other information as appropriate, and make recommendations, including proposed legislation, regarding the Hawaii Teacher Standards Board and submit its findings and recommendations, including all proposed legislation and budget requests, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

SECTION 9

TEACHER LICENSING. Requires the Dean of the University of Hawaii at Manoa College of Education to convene a working group to review and make recommendations to address:

- (1) Licensing rules and their impact on teacher workforce needs in Hawaii;
- (2) Relicensing and tiered licensing options to ensure effective teachers and continuing development of teachers;
- (3) Streamlining processes for reviewing out-of-state and military applicants for licensure;
- (4) Alignment of licensing standards and requirements with the federal No Child Left Behind Act;
- (5) Teacher preparation program alignment with national standards and the role of national accreditation of teacher preparation programs in Hawaii; and
- (6) The role of higher education institutions in assisting teachers in achieving National Board certification.

Further requires the working group to consist of seven members as follows:

- (1) The Dean of the University of Hawaii at Manoa College of Education, or the Dean's designee;
- (2) The Superintendent of Education, or the Superintendent's designee;
- (3) The Chairperson of the Hawaii Teacher Standards Board, or the Chairperson's designee;
- (4) The Executive Director of the Hawaii P-20 Council, or the Executive Director's designee;
- (5) The Executive Director of the Hawaii State Teachers Association, or the Executive Director's designee;

- (6) The Division Administrator of the Professional and Vocational Licensing Division of the Department of Commerce and Consumer Affairs, or the Division Administrator's designee; and
- (7) A member of the National Milken Educators of Hawaii.

Further requires the Dean to submit findings and recommendations of the working group, including any proposed legislation and budget requests, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

SECTION 10

TEACHER STANDARDS BOARD, AUDIT. Requires the Hawaii Teacher Standards Board to review the findings of the Legislative Auditor's Report No. 09-05, and make recommendations for policy and procedural changes necessary to refocus and support the purpose of the Board.

Further requires the Board to consider:

- (1) Procedures to streamline the appeals process, pursuant to section 302A-807, Hawaii Revised Statutes;
- (2) Amendments to the current licensing fees, if required, to meet the operating costs associated with the Board;
- (3) Requirements for training of licensing and administrative personnel to provide increased accessibility and customer service;
- (4) Procedures to improve the coordination of the interim policies and procedures related to the creation of a data interface network consisting of teacher education institutions and the Department of Education to support the free interchange of information valuable to all of the participating organizations; and
- (5) Recommendations as to whether the Board may be authorized to request attendance of a Deputy Attorney General at the meetings of the Board.

Further requires the Board to submit its findings and recommendations, including any proposed legislation and budget requests, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

HB 200, HD1, SD1, CD1

PART III, SECTION 4

HAWAII COMMUNITY-BASED ECONOMIC DEVELOPMENT. Requires the program to submit an expenditure report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 6

BEE MITE INFESTATION. Requires the Department of Agriculture to prepare a report that includes the status of the bee mite infestation and steps to control and treat the infestation and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 15

HARBORS SPECIAL REPAIR AND MAINTENANCE PROJECTS. Requires the Department of Transportation to prepare a report on planned uses and actual expenditures of all special repair and maintenance appropriations as of December 1 for each fiscal year to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 17

HIGHWAYS SPECIAL REPAIR AND MAINTENANCE PROJECTS. Requires the Department of Transportation to prepare a report on planned uses and actual expenditures of all special repair and maintenance appropriations as of December 1 for each fiscal year to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 19

INVASIVE SPECIES PREVENTION, CONTROL, RESEARCH, AND OUTREACH PARTNERSHIP PROGRAMS, STATEWIDE STRATEGIC PLAN FOR. Requires the Department of Land and Natural Resources to prepare a report that identifies short- and long-term needs of the program with specific performance outcomes and all appropriation transfers (state and non-state) to other departments to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 21

PARTNERSHIPS IN COMMUNITY LIVING PROGRAM. Requires the Department of Health to prepare a detailed report on the expenditures for this program and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 22

HEALTHY START PROGRAM. Requires the Department of Health to prepare a detailed report evaluating the current program and making recommendations on how the program will be modified to address the desired public health objectives and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 23

EARLY INTERVENTION PROGRAM. Requires the Department of Health to prepare a detailed report on the expenditures for this program and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 24

CHRONIC DISEASE MANAGEMENT AND CONTROL. Requires the Department of Health to prepare a detailed report on the expenditures for this program and submit the report to the

Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 27

TOBACCO PREVENTION AND CONTROL TRUST FUND. Requires the Hawaii Community Foundation to prepare a detailed report on the financial condition, use of funds, and performance outcomes for the trust fund and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 30

RESPIRE CARE. Requires the Department of Health to prepare a detailed report on the expenditures for respite care and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 31

HAWAII HEALTH SYSTEMS CORPORATION. Requires the Department of Health to prepare a report that includes but not be limited to the following information:

- (1) A comprehensive facility-by-facility review of operations, detailing efficiencies, deficiencies, and any recommendations for corrective action;
- (2) Overall recommendations on improving effectiveness and efficiencies system-wide;
- (3) Determination of responsibilities of facility administration, regional boards, corporate office, and Hawaii Health Systems Corporation corporate board;
- (4) Determination of centralized services required by the facilities to be provided by the corporate office;
- (5) Performance benchmarks to be reported to the Legislature prior to the commencement of each Regular Session and upon request;
- (6) Recommendations on transition plans deemed necessary;
- (7) Evaluation of effectiveness of the current legal structure and adherence to the state procurement code and salary structure; and
- (8) Measures taken to address material control weaknesses and reporting issues cited in audits performed by the State Auditor and Corporation's external auditor.

Further requires the Department to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

PART III, SECTION 34

MARRIAGE REGISTRATION SYSTEM, AUTOMATION OF. Requires the Department of Health to prepare a detailed report on the funds appropriated to automate system and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

PART III, SECTION 36

EDUCATION, NO CHILD LEFT BEHIND. Requires the Department Education to prepare a report that includes evaluations from each educational consultant assigned to each school on the progress of restructuring under No Child Left Behind, and the spending per

school for restructuring under No Child Left Behind and to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 38

EDUCATION, HOMELESS STUDENTS. Requires the Department of Education to prepare a report that includes a detailed breakout of services provided and costs incurred, including outcome and performance reports on each service provided and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 39

EDUCATION, CHARTER SCHOOL BUDGETS. Requires charter schools to prepare a report that includes a detailed breakout of the all means of financing budget for the current and next fiscal year and actual expenditures for the last completed fiscal year for each charter school along with a report of all other funds expended on behalf of each school.

Further requires the Charter Schools Administrative Office to submit this report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 40

EDUCATION, LOCAL SCHOOL COLLECTIVE BARGAINING AGREEMENTS. Requires charter schools to compile a report for each charter school of each use of the authority of each local school to negotiate supplemental collective bargaining agreements with the exclusive representatives of their employees granted by chapter 302B-7, Hawaii Revised Statutes.

Further requires the report to cover the last completed fiscal year and the current fiscal year and that the Charter Schools Administrative Office submit this report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 41

EDUCATION CHARTER SCHOOL PROCUREMENT OF GOODS, SERVICES AND CONSTRUCTION. Requires the charter schools to compile a report for each charter school on the internal policies and procedures for the procurement of goods, services, and construction for each school and also the level of conformity with the goals of public accountability and public procurement practices for each school.

Further requires that the report include an evaluation of the benefits for each charter school as a result of being exempt from the requirements of chapter 103D, Hawaii Revised Statutes, and a discussion on the frequency with which charter schools and their local school boards use the provisions of chapter 103D, Hawaii Revised Statutes.

Further requires the report to cover the last completed fiscal year and the current fiscal year and that the Charter Schools Administrative Office submit this report to the

Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 44

ELECTRONIC MONITORING PILOT PROGRAM FOR ELIGIBLE COMMITTED PERSONS. Requires the Department of Public Safety to prepare a report that includes the following information:

- (1) Status of the electronic monitoring pilot program;
- (2) Appropriate measures of effectiveness;
- (3) Number of committed persons participating in the program;
- (4) Number of violations of program rules and regulations;
- (5) Any instances of participants re-offending;
- (6) Finding and recommendations; and
- (7) Determination of success of program and whether to continue the pilot program.

Further requires the Department to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 45

WARRANTS. Requires the Department of Public Safety to prepare quarterly reports beginning the first quarter of FY 2009-2010 that includes the following:

- (1) Number of warrants served, broken down by type, for the current fiscal year and previous two fiscal years; and
- (2) Per cent of warrants served, broken down by type, for the current fiscal year and previous two fiscal years.

Further requires the Department to submit the report to the Legislature no later than thirty days after the last day of the quarter.

PART III, SECTION 46

DEPUTY SHERIFFS FOR SPECIAL DUTY ASSIGNMENTS. Requires the Department of Public Safety to prepare a report on special duty assignments that shall include the following:

- (1) Implemented policies and procedures covering special duty assignments including a description of how the department is ensuring that all funds received by deputy sheriffs for special duty assignments are reported to federal and state taxing authorities;
- (2) A detail of amounts charged to each state agency for deputy sheriff special duty assignments;
- (3) The total amount received by each deputy sheriff for special duty assignments with state agencies and the amount received for special duty assignments with non-state agencies;
- (4) The average amount of overtime paid, if any, to deputy sheriffs for special duty assignments; and
- (5) The average amount of other income paid to deputy sheriffs for special duty assignments.

Further requires the Department to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 47

DEPARTMENT OF PUBLIC SAFETY EMPLOYEES SICK LEAVE ABUSE AND OVERTIME COSTS. Requires the Department of Public Safety to prepare a report that includes the following information:

- (1) A description of incentive programs maintained by the fund;
- (2) A detail of expenditures from the fund; and
- (3) Overall success of incentive programs, focusing on its impact on sick leave abuse and overtime costs.

Further requires the Department to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 52

ELECTIONS VOTING SYSTEM. Requires the Department of Accounting and General Services to prepare a quarterly report beginning the first quarter of FY 2009-2010 that includes the following:

- (1) A detailed list of expenditures that were procured with the \$2,800,000 in general funds;
- (2) A detailed list of encumbrances or budgeted expenditures for the remainder of FY 2009-2010; and
- (3) The amount expected to lapse, if any.

Further requires the Department to submit the report to the Legislature no later than thirty days after the last day of the quarter.

PART III, SECTION 53

OFFICE OF ELECTIONS EMPLOYEES, CONVERSION TO CIVIL SERVICE. Requires the Department of Accounting and General Services to prepare a report detailing:

- (1) The positions converted to civil service;
- (2) The status of each of the 14.5 positions not yet converted to civil service and reason for the delay of conversion; and
- (3) The actual additional amount needed to convert each of the 14.5 exempt positions to civil service for the most recently completed fiscal year.

Further requires the Department to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III, SECTION 54

ELECTIONS VOTING SYSTEMS CONTRACT, USE OF FEDERAL FUNDS. Requires the Department of Accounting and General Services to prepare a report to include the following:

- (1) All expenditures made from federal funds for the current fiscal year and previous two fiscal years;

- (2) A detailed justification of the amount of federal funds expected to be expended for the 2010 election voting system contract;
- (3) A detailed budget of expenditures of federal funds for fiscal year 2009-2010 and fiscal year 2010-2011; and
- (4) For each general and primary election held within the past 6 years, the number of persons eligible to vote, the number of persons registered to vote, and the number of persons that voted broken down by method of voting.

Further requires the Department to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2010.

PART III, SECTION 55

ELECTIONS OFFICE. Requires the Office of Elections to prepare quarterly reports beginning in the first quarter of fiscal year 2010-2011 to include the following:

- (1) An updated list of vacant positions, noting current recruitment status;
- (2) A detail of travel and overtime expenditures for the quarter, including justification or reason for expenditure;
- (3) A detailed listing of milestones, accomplishments, and activities of the Chief Elections Officer and each section occurring during the quarter; and
- (4) Updated planning timeline for the 2010 elections, including justification of any changes from the previously reported timeline.

Further requires the Department to submit the report to the Legislature no later than thirty days after the last day of each quarter.

PART III, SECTION 56

ELECTION, VOTING PRECINCTS. Requires the Office of Elections to perform an in-depth analysis on voting precincts prior to issuing a request for proposal (RFP) on the State's new election voting system and submit the analysis and findings to the Legislature prior to issuing the RFP.

Requires the Department of Accounting and General Services to submit to the Legislature a timeline for the procurement of the State's new election voting system.

Further requires the Department to inform the Legislature upon completion of each phase in the procurement process and submit any documents related to the procurement process allowable under HRS §103D within five working days after documents are made open to the public.

PART V, SECTION 63

HAWAII COMMUNITY DEVELOPMENT AUTHORITY'S COMMUNITY DEVELOPMENT DISTRICTS AND CAPITAL IMPROVEMENT PROGRAM STAFF COSTS. Requires the Hawaii Community Development Authority to prepare a project funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statute and requires the report to include the details for non-permanent capital improvements program related positions.

Further requires the Authority to submit the budget report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART V, SECTION 64

DEPARTMENT OF TRANSPORTATION, AIRPORTS DIVISION CAPITAL IMPROVEMENTS PROGRAM PROJECT STAFF COSTS. Requires the Airports Division to prepare a project funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statutes and requires the report to include the details for non-permanent capital improvements program related positions.

Further requires the Division to submit the budget report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART V, SECTION 65

DEPARTMENT OF TRANSPORTATION, HMP HARBORS DIVISION CAPITAL IMPROVEMENTS PROGRAM PROJECT STAFF COSTS. Requires the Harbors Division to prepare a project funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statutes and requires the report to include the details for non-permanent capital improvements program related positions.

Further requires the Division to submit the budget report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART V, SECTION 66

DEPARTMENT OF TRANSPORTATION, HIGHWAYS DIVISION CAPITAL IMPROVEMENTS PROGRAM PROJECT STAFF COSTS. Requires the Highways Division to prepare a project funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statutes and requires the report to include the details for non-permanent capital improvements program related positions.

Further requires the Division to submit the budget report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART V, SECTION 67

DEPARTMENT OF LAND AND NATURAL RESOURCES CAPITAL IMPROVEMENTS PROGRAM STAFF COSTS. Requires the Department of Land and Natural Resources to prepare a project funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statutes and that the report include the details for non-permanent capital improvements program related positions.

Further requires the Department to submit the budget report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART V, SECTION 68

DEPARTMENT OF EDUCATION CAPITAL IMPROVEMENTS PROGRAM STAFF COSTS. Requires the Department of Education to prepare a project funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statutes and that the report include the details for non-permanent capital improvements program related positions.

Further requires the Department to submit the budget report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART V, SECTION 69

DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES CAPITAL IMPROVEMENTS PROGRAM PROJECT STAFF COSTS. Requires the Department of Accounting and General Services to prepare a project funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statutes and requires the report to include the details for non-permanent capital improvements program related positions.

Further requires the Department to submit the budget report to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART V, SECTION 70

HAWAII HEALTH SYSTEMS CORPORATION, FUNDING OF PROJECTS. Requires the Hawaii Health Systems Corporation to submit a report to the Legislature identifying the projects funded or intended to be funded no later than twenty days prior to the convening of the Regular Session of 2010.

PART VI, SECTION 81

AIRPORT REVENUE BONDS. Requires the Governor to submit a report to the Legislature of all uses of this authority for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VI, SECTION 82

HARBOR REVENUE BONDS. Requires the Governor to submit a report to the Legislature of all uses of this authority for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VI, SECTION 83

HIGHWAY REVENUE BONDS. Requires the Governor to submit a report to the Legislature of all uses of this authority for the previous twelve month period from

December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VI, SECTION 84

UNIVERSITY OF HAWAII REVENUE BONDS. Requires the Governor to submit a report to the Legislature of all uses of this authority for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VI, SECTION 85

HAWAIIAN HOME LANDS REVENUE BONDS. Requires the Governor to submit a report to the Legislature of all uses of this authority for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 86

GOVERNOR'S DISCRETIONARY POWERS. Any law or provision to the contrary notwithstanding, the Governor may replace general obligation bond funds appropriated for capital improvement projects with general obligation reimbursable bond funds, when the expenditure of such general obligation reimbursable bond funds is deemed appropriate for the project.

PART VII, SECTION 88

CAPITAL IMPROVEMENT PROJECTS, SUPPLEMENTAL ALLOTMENTS FOR. Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 89

AIRPORT PASSENGER FACILITY CHARGE FUNDS, SUPPLEMENTAL ALLOTMENTS FROM. Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 90

CAPITAL IMPROVEMENT PROJECT AUTHORIZED, SUPPLEMENTAL FUNDS FOR. Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 91

GENERAL OBLIGATION BOND FUND FOR CAPITAL IMPROVEMENT PROJECTS TRANSFER TO THE PROJECT ADJUSTMENT FUND. Requires the Governor to notify the

Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 92

APPROPRIATIONS SPECIFIED FOR CAPITAL IMPROVEMENT, SUPPLEMENTAL ALLOTMENTS FOR. Requires the Governor to notify the Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 93

STATE EDUCATIONAL FACILITIES IMPROVEMENT SPECIAL FUND, SUPPLEMENTAL ALLOTMENTS FROM. Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 94

STATE EDUCATIONAL FACILITIES IMPROVEMENT SPECIAL FUND, SUPPLEMENTAL ALLOTMENTS FROM. Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 95

GENERAL OBLIGATION BOND FUND FOR CAPITAL IMPROVEMENT PROJECTS FOR THE UNIVERSITY OF HAWAII TRANSFER TO THE UNIVERSITY OF HAWAII PROJECT ADJUSTMENT FUND. Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 97

CAPITAL IMPROVEMENT PROJECT, SCOPE REDUCTION. Requires the Governor to notify the Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 99

CAPITAL IMPROVEMENT DELEGATION TO OTHER STATE OR COUNTY. Requires the Governor to notify the Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 101

NATURAL DISASTERS OR UNFORESEEN EMERGENCIES, EXPENDITURE OF FUNDS FOR CAPITAL IMPROVEMENT PROJECT FUNDS. Requires the Governor to notify the Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 102

NATURAL DISASTERS OR OTHER UNFORESEEN EMERGENCIES, USE OF APPROPRIATED FUNDS FOR. Requires the Governor to notify the Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 106

FEDERALLY-FUNDED STATE PROGRAMS, FUNDS FOR. Requires the Governor to notify the Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 107

FEDERAL STIMULUS FUNDS FOR OPERATING AND CAPITAL IMPROVEMENT PURPOSES. Authorizes the Governor to allow for an increase in the federal stimulus fund authorization ceiling for the program to accommodate the expenditure of such funds, but requires that prior to the Governor's approval to expend these funds, the Governor submit a report to the Legislature. Requires the report to include the date the program to receive the federal stimulus funds was first notified that additional federal stimulus funds may be available, the date that additional federal stimulus funds were known to be available, and an explanation of the public benefit.

Further requires the Governor to submit a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 108

FEDERAL FUNDS FOR OPERATING AND CAPITAL IMPROVEMENT. Authorizes the Governor to allow for an increase in the federal fund authorization ceiling for the program to accommodate the expenditure of such funds, but requires that prior to the Governor's approval to expend these funds the Governor shall submit a report to the Legislature that include the date when the program to receive the federal funds was first notified that additional federal funds may be available, the date that additional federal funds were known to be available, and the reasons why additional federal fund appropriations were

not sought during the preceding legislative session, and an explanation of the public benefit.

Requires that in the event of federal funds received as a result of a natural or manmade disaster the governor submit notification to the Legislature within five days after the Governor's approval to expend funds has been granted.

Further requires that the Governor submit a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 109

PRIVATE FUNDS OR PROPERTY. Provides that where an agency is authorized to secure funds or other property from private organizations or individuals to be expended or utilized in connection with any authorized program, the agency, with the Governor's approval, may enter into such undertaking, provided that the provisions of the undertaking comply with applicable State constitutional and statutory requirements.

Requires the Governor to notify the Legislature within five days of each use of this proviso and submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 112

APPROPRIATIONS, TRANSFER OF OPERATING FUNDS BETWEEN. Authorizes the Governor to transfer operating funds between appropriations within the same fund and requires the Governor to submit a report to the Legislature within five days of each use of this proviso that includes the date of transfer, the amount of the transfer, the program ID from which funds were transferred, the program ID to which funds were transferred, the impact to the program ID funds are transferred from, and a detailed explanation of the public purposes served by the transfer of resources.

Requires the Governor to submit to the Legislature a summary report containing the aforementioned information for each use of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 113

APPROPRIATIONS FOR THE DEPARTMENT OF HEALTH, HUMAN SERVICES, AND PUBLIC SAFETY. Provides that for the Department of Health, the Department of Human Services, and the Department of Public Safety, the Governor is authorized to transfer operating funds between appropriations within the same fund, within an expending agency, for operating purposes.

Requires the Governor to submit a report to the Legislature within five days of each use of this proviso and that the report includes the date of transfer, the amount of the transfer, the program ID from which funds were transferred, the program ID to which funds were

transferred, the impact to the program ID funds are transferred from, and a detailed explanation of the public purposes served by the transfer of resources.

Further requires the Governor to submit to the Legislature a summary report containing the aforementioned information for each use of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 114

PUBLIC EMPLOYEES, TRANSFER OF. Authorizes each department or agency to transfer positions within its respective authorized position ceiling for the purpose of maximizing the utilization of personnel resources and staff productivity with the prior approval of the Governor.

Requires the Governor to submit a report to the Legislature within five days of each use of this proviso and that the report includes the date of the transfer, the position transferred, the program from which the position was transferred, the program to which the position was transferred, responsibilities of the position prior to transfer, the responsibilities of the position after the transfer, and the manner in which the transfer maximizes the utilization of personnel resources and staff productivity.

Further requires the Governor to submit to the Legislature a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 115

APPROPRIATIONS BASED ON POPULATION AND WORKLOAD DATA. Requires agencies having appropriations which are based on population and workload data as specified in the executive budget document to reduce expenditures below appropriations under procedures prescribed by the Department of Budget and Finance in the event actual population and workload trends are less than the figures projected.

Requires the Department of Budget and Finance to notify the Legislature within five business days of each application of this proviso and submit a report of all applications of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 116

AUDIT SERVICES, TRANSFER OF FUNDS FOR. Provides that with the approval of the Governor, agencies that use appropriations for audit services may delegate that responsibility and transfer funds to internal post audit.

Requires the Governor to submit to the Legislature a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 117

REPAIR AND MAINTENANCE, TRANSFER OF FUNDS FOR. Provides that with the approval of the Governor, expending agencies that use appropriations for plans, land acquisition, design, construction, and equipment for repair and alterations may delegate responsibility and transfer funds to public works - planning, design, and construction (AGS 221) for the implementation of the repair and alterations, when it is determined by the agencies that it is advantageous to do so.

Requires the Governor to submit to the Legislature a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 119

HEALTH CARE FOR INDIGENTS, TRANSFER OF FUNDS FOR. Provides that with the approval of the Governor, the Hawaii Health Systems Corporation in the Department of Health may transfer to the Department of Human Services funds appropriated to the Corporation for the care and treatment of patients, whenever the Department of Human Services can utilize such funds to match federal funds which may be available to help finance the cost of outpatient, acute hospital, or long-term care of indigents or medical indigents in designated critical access hospitals.

Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 120

HEALTH CARE FOR INDIGENTS, TRANSFER OF FUNDS FOR. Provides that with the approval of the Governor, the Department of Health may transfer to the Department of Human Services funds appropriated to the Department of Health for the care and treatment of patients, whenever the Department of Human Services can utilize such funds to match federal funds to finance the cost of outpatient, hospital, or skilled nursing home care of indigents or medical indigents.

Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 121

HEALTH CARE FOR INDIGENTS, AGREEMENTS FOR. Authorizes the Department of Human Services to enter into agreements with the Department of Health to furnish outpatient, hospital, and skilled nursing home care of indigents or medical indigents and to pay the Department of Health for such care.

Requires the Governor to submit a report to the Legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 124

BOND RATING AND SALES, PROTOCOL ACCOUNT FOR IMPROVING. Authorizes the Director of Finance to establish a separate protocol account to be expended at the discretion of the Director for the promotion and improvement of state bond ratings and sales and to submit a detailed report of all expenditures made from the protocol account to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 130

CLAIMS AGAINST THE STATE. Provides that in the event that the amount of settlements and judgments approved by the Legislature in House Bill No. 1016, H.D. 2, S.D. 1, C.D. 1, exceeds program allocations for fiscal year 2009-2010 or fiscal year 2010-2011, a Department, with the approval of the Governor, is authorized to utilize allocated savings determined to be available from any other program within the department and the Governor is authorized to transfer funds between allocations of appropriations within a department for the purposes of paying settlements and judgments of a program.

Requires the Governor to submit a report of all uses of this proviso for the previous twelve month period no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 131

MUNICIPAL LEASE PAYMENTS, FUNDS FOR. Requires the Governor to submit to the Legislature a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 134

PUBLIC EMPLOYEE POSITIONS NOT AUTHORIZED BY THE LEGISLATURE. Requires the Department of Budget and Finance to submit to the Legislature a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART VII, SECTION 135

DEPARTMENT OF TRANSPORTATION AUDIT. Requires the State Auditor to perform a financial audit of the Department of Transportation and report to the Legislature no later than twenty days prior to convening of the Regular Session of 2010.

PART VII, SECTION 136

 - (B) The apportionment should be changed; and
 - (C) Any additional special, trust, or revolving fund should receive a share of the tax; and
- (10) Perform any other function necessary to effectuate the purposes of this part.

AGING IN PLACE AND MULTIGENERATIONAL LIVING. - (1) Building and zoning codes that present barriers to converting an existing single-family dwelling into a multigenerational home, and to:
 - (A) Identify any previous legislative attempts to facilitate the creation of multigenerational homes;
 - (B) Recommend legislation for reasonable and appropriate changes to building and zoning codes that will facilitate the creation of or conversion to multigenerational homes;
 - (C) Draft recommendations to submit to the state Building Code Council that will facilitate the creation of multigenerational housing; and

 - (B) Structural modifications that can be made to dwelling structures to accommodate the most common impairments;
 - (C) The costs associated with the foregoing structural modifications; and
 - (D) Sources of funding, supplies, and voluntary labor to complete the structural modifications, including: suppliers willing to donate or provide at a reduced cost tools, equipment, and supplies; available public or private loan or grant programs that would finance the modifications; and the potential use of building industry apprentices or volunteers to provide labor for the modifications (and to further identify amendments to licensing requirements under title 25, Hawaii Revised Statutes, that may be necessitated by the use of apprentices or volunteers); and
- (3) Mechanisms by which personnel may be trained to analyze and make recommendations for structural modifications to existing structures, and, in particular, to pinpoint:
 - (A) Agencies or individuals who currently engage in assessing homes for structural modification, and evaluating practices for assessments currently in place;
 - (B) Skills necessary to conduct structural modification assessments and the feasibility of introducing training programs relating to these skills in local educational institutions; and
 - (C) The viability of including in the training and assessment process an evaluation team comprising medical, architectural, and construction professionals; and
- (4) The use of universal design principles in new construction projects and renovations of existing structures, prioritizing the investigation of:
 - (A) Incentives that would motivate builders and developers to incorporate universal design principles;
 - (B) Programs used in other states to support universal designs;
 - (C) The existence of industry support for creating a certification program for universal design structures, and the subsequent creation of a symbol signifying universal design certification to be used by real estate professionals and development marketers in their advertising campaigns; and
 - (D) Proposed amendments to existing building and zoning codes to facilitate the incorporation of universal design principles.

Further directs the Task Force to:

- (1) Create a comprehensive guide for older adults and persons with disabilities that lists resources available for structural modification of their homes, including sources of low-cost or free supplies, voluntary labor, and available grants or loan programs;
