FOREWORD

This publication sets forth important information concerning the bills passed by the Hawaii State Legislature during the Regular Session of 2010, which adjourned *sine die* on April 29, 2010. This publication supplements the publication entitled "Bills Passed by the Hawaii State Legislature, Regular Session of 2010" which was issued by the Legislative Reference Bureau in early May 2010. That publication contains a brief description of each bill passed during the 2010 session.

This report contains the following:

- (1) A preliminary index that contains a topical listing of the bills passed in 2010 under broad and general subject matter categories.
- (2) "Laws Affected by Bills Passed" shows sections of the Hawaii Revised Statutes, Hawaiian Homes Commission Act, proposed constitutional amendments, and the Session Laws of Hawaii that are affected by bills passed by the Legislature during the Regular Session of 2010. It also includes a listing of new sections or chapters of the Hawaii Revised Statutes. This table reflects information from the final draft of every bill passed by the Legislature.
- (3) "Status of Bills Passed by the Legislature" is a listing of bills passed, and includes the Act number and approval date, if any, and the appropriate committee report numbers.
- (4) A table of H.B. No. 2200, C.D. 1, Supplemental Appropriations Act of 2010, furnished courtesy of the Tax Foundation of Hawaii, shows the total program appropriations for fiscal years 2009-2010 and 2010-2011.

The above information includes act numbers and approval dates for bills signed into law or vetoed by the Governor as of May 20, 2010. Information on veto overrides is also included.

The "Supplemental Information" publication will also be available through the LRB Library website, at hawaii.gov/lrb/reports. Click on "Session Actions" on the left-hand side of the screen to get to the "Legislative Reference Bureau Systems Office Session Reports" page. Then, scroll down to "Supplemental Information Relating to Bills Passed" and click on the particular session year desired.

For the reader's information, the Governor has 45 days after adjournment *sine die* (not counting Saturdays, Sundays, and holidays) to consider bills for approval.
