FOREWORD

This publication sets forth all of the requests made by the Hawaii State Legislature during the 1998 Regular Session to agencies and officials of the federal, state and county governments, and of quasi-public and private agencies. These requests are contained in acts or bills passed which have yet to be approved by the Governor. These acts or bills include specific requests for submission of information back to the Legislature excluding annual reports. These requests are also contained in resolutions adopted by the Senate (SR) or House of Representatives (HR) or by the whole legislature (SCR or HCR). Dates by which reports and other responses are expected are indicated when specifically set by the Legislature. The names of the agencies involved in the conduct of a study or the execution of a request are underscored.

For the reader's convenience these legislative requests are also grouped together by agencies (see agency index); as well as by subject matter (see subject index).

MISS UNIVERSE PAGEANT, REPORT ON THE. Requires the Hawaii Visitors and
Convention Bureau to report on its tourism marketing plans for the Miss

Universe Pageant to the Legislature no later than thirty days after the release of funds and to submit a report outlining the preliminary results of the appropriation sixty days after the event has taken place. Also requires a final report to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

(HSCR 107-98, 494-98, SSCR 2796, 2976)

EMERGENCY AEROMEDICAL SERVICES SYSTEM, PLAN AND DEVELOPMENT OF. Requires the Department of Health to plan and develop a statewide emergency

aeromedical services system and to report its progress in planning and developing the system to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

(SSCR 2603, HSCR 925-98, 1359-98)

TRAFFIC ENFORCEMENT, PHOTO RED LIGHT IMAGING AND PHOTO SPEED IMAGING DEMONSTRATION PROJECT FOR. Requires each county to submit an interim report

that documents the progress made in implementing the demonstration project and any contract entered into with a private contractor to the Legislature no later than 20 days before the convening of the Regular Session of 1999 and 2000.

Also requires each county to submit a final report to evaluate the effectiveness of the project, including:

- (1) The total fine revenue generated by using the photo red speed imaging detector and photo red light imaging system;
- (2) The number of citations and summonses issued by the photo speed imaging detector and photo red light imaging systems;
- (3) The amount paid to the contractor providing the photo speed imaging detector and photo red light imaging systems;
- (4) The effect of the demonstration project on traffic safety;
- (5) The degree of public acceptance of the project;
- (6) The process of administration of the project;
- (7) A review of the effectiveness of contracts entered into under this Act and the performance of the contractor;
- (8) Recommendations for design or planning changes that might reduce traffic congestion on state or county highways; and
- (9) Findings and recommendations as to whether to continue any contract

entered into pursuant to this Act, make the project permanent, or adopt another alternative.

Requires the final report to include any proposed implementing legislation as may be necessary and be submitted to the Legislature no later than twenty days prior to the convening of the Regular Session of 2001.

HAWAIIAN HEALING PRACTICES BY HAWAIIAN HEALERS, CERTIFICATION OF. Requires Papa Ola Lokahi to convene a panel to consist of members from traditional

native Hawaiian organizations to address issues and recommend legislation relating to the permanent implementation of the purposes of this Act and to submit a final report and recommend legislation to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

Provides that if Papa Ola Lokahi is not prepared to submit a final report, they shall submit an interim report and submit a final report together with recommended legislation no later than twenty days prior to the convening of the Regular Session of 2000.

SB 2092, SD1, HD1, CD1

ENERGY EFFICIENCY AND SUSTAINABILITY, COST-EFFECTIVE MEANS TO INCREASE. Establishes a task force within the Department of Business, Economic

Development, and Tourism to explore the most cost-effective means of increased energy efficiency and sustainability by:

- (1) Examining alternatives to encourage the efficient use of energy;
- (2) Considering the merits of active participation in the federal Million Solar Roofs Program, a partnership with businesses, communities, federal, state, and local governments, and utilities to install solar energy systems on one million roofs across the United States by the year 2010; and
- (3) Make recommendations on the most cost-effective means for increased energy efficiency.

Requires the Department to ensure that there is representation on the task force from the Department, the solar industry, the utilities industry, and the building industry.

Also requires the task force to report its findings and recommendations to the Legislature no later than January 1, 2002.

SB 2211, SD2, HD1, CD1

COMPUTER TECHNOLOGY AND A LANGUAGE OTHER THAN ENGLISH, STUDENT COMPETENCY IN. Requires the Department of Education, after consulting with parties

involved in public education and after considering relevant national standards to develop a plan including a timetable to implement that all pupils shall be progressively competent in the use of computer technology and the course of study and instruction for the first twelve grades shall enable all students to meet progressive standards of competency in a language in addition to english.

Also requires the Department to submit a copy of the plan to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART II

BUDGETING SYSTEM, TRANSFORMING THE STATE'S ACCOUNTING SYSTEM AND THE BUDGETING SYSTEM TO A PERFORMANCE-BASED. Establishes a committee to develop

and oversee the implementation of plans for the transformation of the state government's budgeting, accounting, and procurement systems. Requires the committee to consist of nine members which includes the legislative analyst.

Requires the eight other members to be appointed by the Governor and to include one member appointed from a list nominated by the Senate President, one member appointed from a list nominated by the Speaker of the House of Representatives, two members with budgetary, accounting, financial services, or comparable public accounting experience, and four members from among the members of the Governor's cabinet including the Director of Finance and the Comptroller or their designees.

Requires the committee to select three departments that differ in function and organization to develop prototype models of implementation and to submit annual reports of its plans, recommendations, and implementing actions to the Legislature no fewer than fifteen days prior to the convening of the Regular Sessions of 1999, 2000, and 2001.

MEDICAL, DENTAL, AND MENTAL HEALTH SERVICES OR TREATMENT, ASSESSMENT OF FEES ON DETAINEES AND INMATES FOR. Requires the Department of Public Safety to

implement the assessment of fees for medical, dental, or mental health services for treatment upon the request of the detainee or committed person or due to their intentional infliction of injury to themselves.

Also requires the Department to submit a report to the Legislature that summarizes the total money deducted from inmate accounts and an estimate of savings to the Department one year after the start of the implementation.

PART I, SECTION 12

CONVENTION CENTER, MANAGEMENT AUDIT OF THE. Requires the Auditor to submit a management audit report on the effectiveness of the steps taken by the Convention Center Authority to resolve traffic, noise, and other outstanding claims against the authority to the Legislature by February 28, 1999. Also requires an interim report to be submitted by September 30, 1998.

SB 2297, SD2, HD1, CD1

PATIENT RIGHTS AND RESPONSIBILITIES IN REGARDS TO HEALTH CARE, REVIEW OF. Requires the Insurance Commissioner to convene a health care consumer rights

and responsibilities task force to review various laws which provide

protection of patient rights and responsibilities in regard to health care. Requires at least one representative from the Department of Health, the

Department of Labor and Industrial Relations, a health insurance company, a

mutual benefit society, a health maintenance organization, the American

Association of Retired Persons, the Hawaii Coalition for Health, the Hawaii

Business Health Coalition, the Legal Aid Society of Hawaii, the Hawaii

Medical Association, an organization that represents nurses, and a hospital

or an organization that represents hospitals be a member of the task force.

Requires the task force to submit its preliminary findings and recommendations to the legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART II, SECTION 9

ENVIRONMENTAL INITIATIVE PROGRAM, PROJECT PROPOSAL FOR. Establishes the Hawaii strategic environmental initiative task force to develop a

competitive and viable project proposal for submission for a matching-grant award from the Council of State Governments United States-Asia Environmental Initiatives Program. Requires the task force to consist of members representing the Department of Health, the Office of Environmental Control,

the Public Utilities Commission, and the University of Hawaii. Requires the

Director of Business, Economic, Development, and Tourism to appoint four

members with experience in environmental technology, urban environmental infrastructure, and pollution management or prevention technology, processes, or services.

Requires the task force to submit its report and project proposal to the Legislature no later than October 30, 1998.

SB 2386, SD2, HD2, CD1

COORDINATED CARE ORGANIZATION SYSTEM, MONITORING AND STUDYING OF.

Establishes a coordinated care organization review task force attached to

the Department of Labor and Industrial Relations to monitor and study the

coordinated care organization system. Requires the task force to consist of ten members to include the Director of Labor and Industrial Relations,

Insurance Commissioner, and eight persons appointed by the Director of Labor

and Industrial Relations. Requires the Legislative Reference Bureau to

assist the task force in gathering information and data for the study. Also requires the task force to submit a report of its findings and recommendations to the Legislature and the Governor no later than twenty days prior to the convening of the Regular Session of 2002.

Also requires the Bureau to conduct a study of coordinated care organizations and report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2002.

ELECTIONS, CAMPAIGN FINANCING SYSTEM, STUDY OF. Requires the Campaign

Spending Commission, in cooperation with the League of Women Voters, Common

Cause Hawaii, Hawaii Clean Elections, and other relevant stakeholders to

conduct a comprehensive study of the campaign financing system in Hawaii and report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2000, including information about the pilot program proposed in this model Act.

SB 2803, SD2, HD2, CD1

SMALL BUSINESS DEFENDER, REPORT OF THE. Requires the Small Business

Defender to submit an annual report to the Legislature detailing its

activities and expenditures no later than twenty days prior to the convening of the Regular Session. Act to be repealed on June 30, 2022.

SB 2821, HD1

FOREIGN CAPITAL DEPOSITORIES UNDER THE CODE OF FINANCIAL INSTITUTIONS, FEASIBILITY OF CHARTERING. Establishes a foreign capital depository task

force within the Department of Business, Economic Development, and Tourism.

Requires the members of the task force to include the Director of Business,

Economic Development, and Tourism, Commissioner of Financial Institutions,
Director of Taxation, Prosecuting Attorney of the City and County of
Honolulu, Attorney General, Chief of Police of the City and County of
Honolulu, a member of the banking community, and any other agency deemed
appropriate by the Director of Business, Economic Development, and Tourism.

Requires the task force to investigate the feasibility of chartering foreign capital depositories in the State under the code of financial institutions, including economic development and business opportunities that may result, marketing requirements necessary to attract foreign depositors, changes necessary in Hawaii law to attract foreign depositors and deter possible criminal activity, costs involved, expected benefits, changes necessary to conform the Montana law to Hawaii law, identification and separation of pertinent issues, identification of potential uses to commit violations of state criminal laws and any changes in statutes, rules, or procedures needed to prevent such use, examination of other legal entities or mechanisms that would serve the same purpose as a depository, and tax treatment.

Requires the Director of Business, Economic Development, and Tourism in consultation with the task force, to submit a report to the Legislature including findings, recommendations, and implementing draft legislation no later than twenty days prior to the convening of the Regular Session of 1999.

COMPUTER SYSTEMS AND THE YEAR 2000 COMPLIANCE, REPORT ON. Requires the Department of Accounting and General Services to report for all state

departments in the executive branch on the progress of efforts to address the year 2000 problems to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

SB 3076, SD1, HD1, CD1

CONTRACTS OFFICE, ESTABLISHMENT OF. Requires the directors for the

Department of Health and Department of Human Services to develop a plan of implementation to establish the Contracts Office and report to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

Also requires the Director of the Contracts Office to report on the

effectiveness of the implementation of this Act, including the extent to which the Contracts Office has been able to promote efficiency, avoid duplication, and maximize the use of resources, and the need for any changes in the functions or structure of the Contract Office, together with proposed legislation. Requires the report to be made to the Legislature no later than twenty days prior to the convening of the Regular Session of 2000.

HOMELESS ASSISTANCE, EXPENDITURE REPORT ON. Requires the executive Director
of the Housing and Community Development Corporation of Hawaii to submit a
report that details the current expenditures of the Corporation for
providing homeless assistance and assess and identifies the funding needs
for providing homeless assistance during the fiscal years 1999-2000 and
2000-2001 to the Legislature no later than twenty days prior to the
convening of the Regular Session of 1999.

HB 1332, HD2, SD2, CD1

STATE AGRICULTURAL WATER USE AND DEVELOPMENT PLAN, SUBMITTAL OF THE.
Requires the Chairperson of the Board of Agriculture to submit the State
Agricultural Water Use and Development Plan to the Legislature no later than
twenty days prior to the convening of the Regular Session of 2000.

HB 1824, HD2, SD2, CD1

HAWAII HEALTH SYSTEMS CORPORATION, DELINQUENT ACCOUNTS OWED TO. Requires
the Department of the Attorney General to submit a report to the Legislature
identifying all delinquent accounts owed to the Hawaii Health Systems
Corporation that were handled by the Attorney General through December 31,
1998, and the disposition of those accounts.

INTRA-ISLAND WATER FERRY TRANSPORTATION SYSTEM, IMPLEMENTATION OF. Requires
the Department of Transportation to submit a report to the Legislature on
the intra-island water ferry transportation system no later than thirty days
prior to the convening of the Regular Session of 2000.

HB 2496, HD2, SD1, CD1

INDIGENT LEGAL SERVICES, SURCHARGE ON CIVIL CASES TO FUND. Requires the
Commission on Access to Justice to review the filing fee surcharge program
to determine whether it is meeting the civil legal needs of indigent persons
and to presents its findings and recommendations to the Legislature no later
than January 1, of each year. Act to be repealed on June 30, 2002

PART III, SECTION 6.1

FILM MAKERS IN HAWAII, ASSISTANCE OF. Requires the Department of Business,

Economic Development, and Tourism to submit a report detailing the assistance provided to Hawaii-based film companies to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 6.2

BUSINESS, CREATING A POSITIVE ENVIRONMENT FOR. Requires the Military Affairs Council to act as a liaison between state and county government, the private sector and the military community to create a positive environment for business.

Requires a report detailing the activities and expenditures of the Council to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 7

HAWAII VISITORS AND CONVENTION BUREAU, REPORT ON EXPENDITURES OF FUNDS OF THE. Requires a report detailing the expenditure of funds by the Hawaii

Visitors and Convention Bureau on the:

- (1) Salaries, benefits, related taxes, and office rent for the Bureau;
- (2) Pro Bowl;
- (3) Seniors Skins;
- (4) Mercedes Championships;
- (5) KaaNapali Classic;
- (6) PGA Grand Slam of Golf;
- (7) Sony Hawaiian Open;
- (8) Hawaii Winter League Baseball;
- (9) Royal Hawaiian Rowing Challenge;
- (10) Hawaii International Film Festival;
- (11) Island Chapter marketing;
- (12) Poipu Beach resort destination;
- (13) King Kamehameha Celebration Commission; and
- (14) Visitor Aloha Society of Hawaii

to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 7.1

HAWAII VISITORS AND CONVENTION BUREAU, REPORT ON EXPENDITURES OF FUNDS. Requires a report detailing the expenditure of funds by the Hawaii Visitors

and Convention Bureau on the:

- (1) Salaries, benefits, related taxes, and office rent for the Bureau;
- (2) Pro Bowl;
- (3) Seniors Skins;
- (4) Mercedes Championships;
- (5) Kaanapali Classic;
- (6) PGA Grand Slam of Golf;
- (7) Sony Hawaiian Open;
- (8) Hawaii Winter League Baseball;
- (9) Tour of Champions Bike Race;
- (10) Royal Hawaiian Rowing Challenge;
- (11) Island Chapter marketing;
- (12) King Kamehameha Celebration Commission;
- (13) Haleiwa Arts Festival; and
- (14) Visitor Aloha Society of Hawaii

to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 9

OLYMPIC RELATED EVENTS IN HAWAII, EXPENDITURE REPORT ON. Requires the State Tourism Office to submit a report on the expenditure of funds for olympic related events in Hawaii to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 12

AGRIBUSINESS DEVELOPMENT AND RESEARCH, REPORT ON. Requires the Department of Agriculture to submit an itemized report on ornamental nursery research, taro research, coffee research, macadamia research, State Farm Fair, plant alien pest program, vegetable crop research, papaya transgenic seed, alien species education program, pineapple research, cut flower research, tropical fruit research, and contingency emergency research for diversified agriculture to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999. Requires the report to include progress being made with each specific commodity that is funded for research, and projected funding, if necessary, for the continuation of each of the research projects with justification for recommended funding in future years.

PART III, SECTION 30

PACIFIC CARGO NETWORK SYSTEM, MASTER PLAN TO ESTABLISH. Requires the Department of Transportation to submit a detailed expenditure plan and

status report on the development of a master plan to establish a Pacific Cargo Network System to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999 and a final plan twenty days prior to the convening of the 2000 Regular Session.

PART III, SECTION 52

HAWAII HEALTH SYSTEMS CORPORATION, FISCAL AND MANAGEMENT AUDIT OF. Requires the Legislative Auditor to perform a fiscal and management audit of the

Hawaii Health Systems Corporation and that this report include an analysis of accounting procedures, procurement practices, and personnel and fiscal accountability.

Also requires the Office of the Auditor to provide this report to the

Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 56.1

ADULT MENTAL HEALTH PROGRAM DIRECT SERVICES, PRIVATE PROVIDERS FOR. Requires the Legislative Auditor to examine to what extent the direct

services which are currently provided in the adult mental health program could be assumed by private providers.

Also requires the Office of the Auditor to provide the results of this study

to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 57

CHILD AND ADOLESCENT MENTAL HEALTH PROGRAMS, PRIVATIZATION OF. Requires the Legislative Auditor to conduct a study on the privatization of the child and

adolescent mental health program to include analysis of current operating procedures, current program effectiveness, cost benefits of privatization, and the effectiveness of privatization.

Also requires the Office of the Auditor to provide the study to the

Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 66.2

MEDICAID LONG-TERM DEMONSTRATION PROJECT, DEVELOPMENT OF. Requires the Department of Human Services to provide a report detailing the

expenditures made and the potential cost savings to be realized from reimbursable services resulting from the waiver application to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 67

PROGRAM OF ALL-INCLUSIVE CARE FOR THE ELDERLY, SELF-SUFFICIENCY OF. Requires the PACE Hawaii Program to submit a report detailing program costs including unfunded liabilities and revenues necessary to evaluate self-sufficiency to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 85

PERSONNEL MANAGEMENT SPECIALIST IV POSITIONS, TRANSFER OF. Requires the Department of Education to submit reports to the Legislature of the internal savings from EDN 200, EDN 300, EDN 400, and EDN 500 or combination thereof used to fund 4 personnel management specialist IV positions transferred from the Department of Human Resources Development.

PART III, SECTION 91.1

STUDENT TRANSPORTATION PROGRAM, AUDIT OF. Requires the Auditor to conduct an audit of the student transportation program. Requires the report to include an analysis of accounting procedures including review of internal controls relating to the collection of fees, procurement practices, and personnel and fiscal accountability. Also requires the Auditor to determine the operating costs of this program, review the expenditures for the program, and determine if all expenditures are for operating costs, or if expenditures are being made for costs other than operating costs, and identify those nonoperating costs, and provide this report to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 102.2

HAWAII YOUTH SPORTS AND FITNESS PROGRAM. Requires a report on the progress of the Hawaii youth sport fitness program to be submitted to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 118.1

STATE PARKS AS SCENIC VIEWING SITES, USE OF. Requires the Department of Land and Natural Resources to work with the Department of Business, Economic Development, and Tourism to develop a pilot project for the use of state parks as scenic viewing sites.

Requires the Department to submit a report to the Legislature no later than twenty days prior to the convening of the Regular Session of 1999.

PART III, SECTION 120.1

INSURANCE REGULATORY SERVICES TO CONSOLIDATE FUNDS WITHIN THE DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS, EVALUATION OF THE.
