FOREWORD

This publication sets forth important information concerning the bills passed by the Hawaii State Legislature during the Regular Session of 2012, which adjourned *sine die* on May 3, 2012. This publication supplements the publication entitled "Bills Passed by the Hawaii State Legislature, Regular Session of 2012" which was issued by the Legislative Reference Bureau in early May 2012. That publication contains a brief description of each bill passed during the 2012 session.

This report contains the following:

- (1) A preliminary index that contains a topical listing of the bills passed in 2012 under broad and general subject matter categories.
- (2) "Laws Affected by Bills Passed" shows sections of the Hawaii Revised Statutes, Session Laws of Hawaii, Hawaiian Homes Commission Act, and the proposed constitutional amendments that are affected by bills passed by the Legislature during the Regular Session of 2012. It also includes a listing of new sections or chapters of the Hawaii Revised Statutes. This table reflects information from the final draft of every bill passed by the Legislature.
- (3) "Status of Bills Passed by the Legislature" is a listing of bills passed, and includes the Act number and approval date, if any, and the appropriate committee report numbers.
- (4) A table of Act 106, H.B. No. 2012, C.D. 1, Supplemental Appropriations Act of 2012, furnished courtesy of the Tax Foundation of Hawaii, shows the total program appropriations for fiscal years 2011-2012 and 2012-2013.

The above information includes act numbers and approval dates for bills signed into law or vetoed by the Governor as of June 28, 2012.

The "Supplemental Information" publication is available through the LRB Library website, at hawaii.gov/lrb/reports. Click on "Session Reports" on the left-hand side of the screen to get to the "Legislative Reference Bureau Systems Office Session Reports" page. Then, scroll down to "Supplemental Information Relating to Bills Passed" and click on the particular session year desired.

For the reader's information, the Governor has 45 days (July 10, 2012) after adjournment *sine die* (not counting Saturdays, Sundays, and holidays) to consider bills for approval.
